FACTS: In, 2001, Plaintiff Teresa Gonzalez, then 15 years of age, was riding in a family minivan driven by her father along with six other passengers. A commercial farm truck owned by Dresick Farms allegedly ran a stop sign and hit the minivan, causing it to roll repeatedly. The truck pierced the van's side, literally striking Teresa in the face.

Defendant Dresick Farms denied liability for six years, but finally admitted negligence on the part of the driver shortly before trial. The trial proceeded solely on the issue of damages.

INJURIES: Teresa suffered facial avulsion degloving (the flesh of her face was torn off), and several fractures to her skull and face. She has had 21 different facial surgeries. Gonzalez, now 21 years of age, was unable to finish high school and will need more surgery along with treatment for depression.

JURY TRIAL: Length, one month; Deliberation, two days

RESULT: Jury awarded Teresa \$5.6 million. (\$2.5 million for pain and suffering, \$1.2 million for ongoing medical expenses and \$1.9 million for other expenses).

OTHER INFORMATION: This is believed to be the largest personal injury verdict in Imperial County to date.
